

1. CAPACITY

- 1. All transactions between <u>offeror</u> and <u>acceptor</u> is understood to be <u>private</u> and <u>without the united states</u> and exclusively for the benefit of the Kingdom of Jesus the Christ.
- 2. Offeror and acceptor are understood to be ministers exchanging levitical giftings, service for compensation.
- 3. Exchange of <u>levitical giftings</u> shall never be confused for income as defined <u>within the united states</u>.

2. SERVICES

- 1. The Privateer Package shall include;
 - A. Collaboration between <u>offeror</u> and <u>acceptor</u> in creation of contracts and agreements for the purpose of ministry or House structuring.
 - B. Registrar services which serve the <u>acceptor</u> with an official registry seal and filing system at the offices of DeHijo Ministerial Services. The registered files shall be maintained by DeHijo Ministerial Services and made available to the <u>acceptor</u>, upon request, in a certified format. Mailing services are not included in the fee structure of the <u>offeror</u>. However, the <u>offeror</u> shall mail the certified record upon postage remittance being accepted. - F. The cost of the Agent Package shall be \$99 monthly with an agreement to commit for twelve months. Each future commitment shall also be for twelve months. Costs of services are locked in at the rate agreed to at the beginning of the twelve month commitment.

3. TIMELINESS OF SERVICES RENDERED

1. All work done by DeHijo Ministerial Services shall be done as received from the <u>acceptor</u>, in the order the work is received within a 24 [twenty-four] hour period.

4. TIMELINESS OF COMPENSATION FOR SERVICES RENDERED

1. <u>Acceptor</u> shall establish a date monthly to send a check, money order, or silver transfer to <u>offeror</u>. The date chosen by the acceptor shall be the date the compensation is due each month.

5. BREACH OF CONTRACT TERM AND CONDITIONS

- 1. A Breach of the contract's terms and conditions shall be worked out in the following way;
 - 1. An attempt to make an arrangement to cure the breach between the <u>offeror</u> and the <u>acceptor</u> shall be made on shopyourfarm.com by video conference call within 72 hours of the breach of contract terms and conditions. If no arrangement is made;
 - 2. An <u>arbitrator</u> on the Council of the Holy Nation of the Ecclesia will be brought in to witness a second attempt at resolving the breach of contract of the terms and conditions within 72 hours of the failure of step 1. If no arrangement is made;

5. BREACH OF CONTRACT TERM AND CONDITIONS CONTINUED...

- 3. The <u>issue</u> will be brought before the Holy Nation of the Ecclesia Council for settlement as soon as possible. The breach shall be corrected upon instruction of the Council within 10 [ten] days of the meeting. If not;
- 4. A lien for the full amount of one year of service shall be placed by the <u>offeror</u> on the <u>acceptor</u> any time after the 10 [ten] days.

6. CANCELLATION

1. The contract may be canceled by <u>request in writing</u> by the <u>acceptor</u> anytime during the contract duration. However, neither the contract nor any obligations under it can be voided during the 365 days that the contract and it's obligations are enforced under the terms and conditions of the contract.

7. PRIVACY POLICY

1. Due to the nature and importance of House and Ministry governance, DeHijo Ministerial Services shall adhere to the strictest of privacy policies. No information disclosed to <u>offeror</u> by the <u>acceptor</u> shall be shared or disseminated to anyone outside the terms and conditions of this contract. Any breach of this privacy policy immediately cancels this contract with no further obligation to it. Furthermore, all papers belonging to the <u>acceptor</u> shall mailed to the <u>acceptor</u>'s address on file within 10 days or a full refund by the offeror is guaranteed. Arbitration rules apply!

8. UPDATES TO TERMS AND CONDITIONS

From time to time, as it <u>benefits</u> both the <u>offeror</u> and the <u>acceptor</u>, updates will be added to the terms and conditions of the contract. All updates shall be made in writing on letterhead of the House of DeHijo, as seen hereon.

OFFEROR: The party offering the contract for services.

REQUEST IN WRITING: A writ under a letterhead and seal of a House of the Holy Nation of the Ecclesia.

WITHIN THE UNITED STATES: Having to do with being under the statutes of the united states.

WITHOUT THE UNITED STATES: Having nothing to do with the united states but outside of its statutes.
